Expand terminally ill Nevadan's "Right to Try" pioneering treatments

CCCN Supports AB 188, Kasama

Nevada's Right to Try law currently permits physicians to prescribe treatments that are being used in clinical trials to consenting patients who have been diagnosed with terminal life-threatening disease. The physicians at Comprehensive are always exploring ways to utilize the most innovative options to care for our patients and want them to have access to all treatment options available. AB 188 sponsored by Assemblywoman Kasama would expand the Right to Try law to include options for targeted treatments for individual patients based on their genetics and DNA.

Expand patient access to tests that help determine the best treatment

Progress in improving cancer outcomes increasingly involves the use of precision medicine. Biomarker testing can help determine the best treatment for a patient.

- Passage of this bill would ensure expedited approval and sufficient coverage of biomarker testing for all Nevada cancer
 patients. This is an incredibly important step forward in expanding timely access to precision medicine for some of the most
 vulnerable patients in our state.
- New advances in precision medicine are rapidly altering the way physicians diagnose and treat cancer. Availability of biomarker testing that factor in a patients' genomic and cellular profile means that truly customized treatments are closer than ever before. As more and more of these targeted therapies are being developed there has also arisen a companion demand for continued access to associated biomarker testing.

Support Affordable Mammogram Screening

CCCN Supports SB 330, Lange

SB 330, which would eliminate out-of-pocket costs for medically necessary diagnostic and supplemental breast imaging under most insurance is vitally important to many of our patients. Breast cancer screening and follow-up diagnostics have led to significant increases in the early detection of breast cancer in the past 30 years – reducing breast cancer mortality in the U.S. by 40 percent. Unfortunately, patients requiring follow-up imaging and those at a higher risk of breast cancer (who are initially screened with more advanced imaging) will likely face hundreds to thousands of dollars in out-of-pocket costs.

Ensure physicians access to affordable medical malpractice insurance

CCCN opposes ongoing efforts to overhaul Nevada's medical malpractice insurance system

Medical malpractice reform passed the Nevada Legislature unanimously in that 2002 Special Session. Nearly 60% of voters approved reforms in a 2004 ballot initiative designed to keep doctors in Nevada. If these existing reforms are rescinded, patients may experience greater problems in accessing care will cause medical malpractice insurance premiums to increase to unaffordable rates. Nevada already has a well-documented physician shortage and medical malpractice insurance policies being proposed by some will only exacerbate the problem.
